<u>Narrator</u>. " Christian is standing outside a bakery, looking at all the delicious food, when she bumps into someone."

Chr. "Oh, I'm so sorry!...I didn't see you there."

MM. "That's alright...I was engrossed in all this adorable food."

Chr. "Me too....This is Disneyland!"

MM. "Isn't it?...It's Heaven."

Chr. "I'm just deciding what to get for lunch."

MM. "Me too, it's hard to choose isn't it?"

Chr. "Terribly...Who ever thought buying lunch could be such an ordeal?"

MM. "Yes, who?...What are you thinking of buying?"

Chr. "I should be having a salad roll."

MM. "A salad roll...When there's all this proper food?"

Chr. "Yes."

MM. "Salad rolls are for sheep!"

Chr. "That's what I always say!"

MM. "Because it's true...Who wants a salad roll?...Not me...Come on...Be daring!"

Chr. "Okay....Not me either."

MM. "That's the spirit."

Chr. "What are you having?"

MM. "I've been looking at those custard squares."

Chr. "Me too....We must have the same taste?"

MM. "We must....And that cream cake?....Now that's a real taste tempting experience."

Chr. "Ha!...That's just what I've been thinking."

MM. "Good girl."

Chr. "I used to love them....But now I'm so overweight."

MM. (Looking Chr. Up and down). "Overweight?...You?...No, I think you need fattening up!"

Chr. "I've been hoping someone would say that to me."

MM. "Well this is your lucky day!...You should celebrate!'

Chr. "Celebrate?"

MM. "Yes....It's not every day you get called thin."

Chr. "Thin?...Me?"

MM. "Positively...Would I lie to you?"

Chr. "Well...In that case I should celebrate!"

MM. "In style...Ohh...Look at those donuts....Mmm, all that lovely cream?"
